4. Further, admissions shall not be made until Recognition Order under Regulations 7(16) of the NCTE (Recognition Norms and Procedure) Regulations, 2014 is issued by the **Southern Regional Committee**, NCTE and thereafter obtaining the affiliation from the concerned affiliating body.
